Now Accepting Nominations to the Board

The Board of Directors appointed the Nominating Committee on November 21, 2023 which consists of committee chair **Robert Curtis**, and committee members **Gerry Cox** and **Michael Whalen**. Nominating Committee Chairman **Curtis** can be contacted through Donna Cochran at 207-427-5956. The Nominating Committee has nominated incumbent **Joseph Manza** to serve a 3-year term. The nominee has agreed to have his name placed in nomination for election and to serve as Director for the stated term. Biographical information is included with this notice. When there is only one nominee for any vacancy, there will be no nominations from the floor; the election will be determined by plurality vote and will not be conducted by ballot.

Steps to Apply to Serve on the Board

All candidates must possess the following qualifications:

- Must be a member of Downeast Credit Union and be at least 18 years of age.
- Must not have been convicted of any criminal offense involving dishonesty or a breach of fiduciary duty. Section 205 (d) of the National Credit Union Act requires that any person so convicted must report such offenses to the Administration who will make a determination whether such person should be allowed to hold office.

Article XVI, Section 4, of the Credit Union Bylaws prohibits any Director, committee member, officer, agent or employee of the credit union from participating in the deliberation of any activity to which he/she has a direct or indirect pecuniary interest.

Procedure for submitting nominations by petition: The nominee will submit a petition signed by 1% of the credit union's membership. Your credit union has more than 22,000 members; resulting in approximately 220 signatures needed. The closing date for accepting nominations by petition is February 3, 2024.

The mailing address is PO Box 130, Baileyville, ME 04694. Qualified nominees must provide to the credit union a signed statement that they are agreeable to nomination and are willing to serve, if elected, no later than March 13, 2024.
